

Booksource.com Terms of Service

Updated June 2017

These terms and conditions (the "Terms of Service") govern your access to and use of Booksource's websites and mobile applications that link to or reference these Terms of Service (collectively, the "Service"). By accessing or using the Service, you are agreeing to these Terms of Service and concluding a legally binding contract with GL Group, INC ("Booksource"). Do not access or use the Service if you are unwilling or unable to be bound by the Terms of Service.

1. Definitions

1. Parties

"You" and "your" refer to you, as a user of the Service. A "user" is someone who accesses, browses, crawls, scrapes, or in any way uses the Service. "We", "us", and "our" refer to Booksource.

2. Content

"Content" means text, images, photos, audio, video, location data, and all other forms of data or communication. "Your Content" means Content that you submit or transmit to, through, or in connection with the Service, such as ratings, reviews, check-ins, and messages. "User Content" means Content that users submit or transmit to, through, or in connection with the Service. "Booksource Content" means Content that we create and make available in connection with the Service. "Third Party Content" means Content that originates from parties other than Booksource or its users, which is made available in connection with the Service. "Site Content" means all of the Content that is made available in connection with the Service, including Your Content, User Content, Third Party Content, and Booksource Content.

2. Changes to the Terms of Service

We may modify the Terms of Service from time to time. When changes are made, we will notify you by making the revised version available on this webpage, and will indicate at the top of this page the date that revisions were last made. You should revisit these Terms of Service on a regular basis as revised versions will be binding on you. Any such modification will be effective upon our posting of new Terms of Service. You understand and agree that your

continued access to or use of the Service after any posted modification to the Terms of Service indicates your acceptance of the modification.

3. Translation

We may translate these Terms of Service into other languages for your convenience. Nevertheless, the English version governs your relationship with Booksource, and any inconsistencies among the different versions will be resolved in favor of the English version.

4. Using the Service

1. Eligibility

To access or use the Service, you must be 18 years or older and have the requisite power and authority to enter into these Terms of Service. You may not access or use the Service if you are a competitor of ours.

Booksource is a wholesale supplier of authentic children's literature for the education industry, and as such, only ships to commercial addresses.

2. Permission to Use the Service

We grant you a limited, non-exclusive, non-assignable, non-transferable license to use the Service, subject to the restrictions in these Terms of Service. Your use of the Service is at your own risk.

3. Site Availability

The Service may be modified, updated, interrupted, suspended or discontinued at any time without notice or liability. These Terms of Service will govern any such modified or updated Service, unless such update is accompanied by a separate agreement, in which case the terms of that agreement will govern.

4. User Accounts

You must create an account and provide certain information about yourself in order to use some of the features that are offered through the Service. You are responsible for maintaining the confidentiality of your account password. You are also responsible for all activities that occur in connection with your account. We reserve the right to close your account at any time for any or no reason.

5. Communications from Booksource and other Users

By creating an account, you agree to receive certain communications in connection with the Service. For example, you might receive promotional email updates. You may opt out of non-essential emails at any time.

6. Representations

You represent and warrant to Booksource that you will use the Service only for lawful purposes. You represent and warrant that you will use the Service in a safe manner and that you will not access the Service while operating a motor vehicle or in any other unsafe circumstances which may cause harm to yourself or others. You agree you will be solely responsible for damages or injuries caused to yourself or others as a result of your use of the Service in a dangerous or unsafe manner. You represent and warrant that you are authorized to enter into these Terms of Service, and that you will at all times comply with these Terms of Service and all local, state, federal and international laws and regulations that may apply to your use of the Service.

5. Content

1. Our Right to Use Your Content

We may use Your Content in a number of different ways, including publicly displaying it, reformatting it, incorporating it into advertisements and other works, creating derivative works from it, promoting it, distributing it, and allowing others to do the same in connection with their own websites and media platforms ("Other Media"). As such, you hereby irrevocably grant us world-wide, non-exclusive, royalty-free, sub licensable, transferable rights to use Your Content for any purpose. You also irrevocably waive, and cause to be waived, against Booksource and its users claims and assertions of moral rights or attribution with respect of Your Content. By "use" we mean use, copy, publicly perform or display, distribute, modify, translate, and create derivative works of Your Content.

2. Ownership

As between you and Booksource, you own Your Content (see 5. Content, 1.Our Right to Use Your Content for usage). We own the Booksource Content, including but not limited to visual interfaces, interactive features, graphics, design,

compilation, computer code, products, software, and all other elements and components of the Service excluding Your Content, User Content and Third Party Content. We also own the copyrights, trademarks, service marks, trade names, and other intellectual and proprietary rights throughout the world (the "IP Rights") associated with the Booksource Content and the Service, which are protected by copyright, trade dress, patent, trademark laws and all other applicable intellectual and proprietary rights and laws. As such, you may not modify, reproduce, distribute, create derivative works or adaptations of, publicly display or in any way exploit any of the Booksource Content in whole or in part except as expressly authorized by us. Except as expressly and unambiguously provided herein, we do not grant you any express or implied rights, and all rights in and to the Service and the Booksource Content are retained by us.

3. Advertising

4. Other

We reserve the right to remove, screen, edit, or reinstate User Content from time to time at our sole discretion and without notice to you. We have no obligation to retain or provide you with copies of Your Content, nor do we guarantee any confidentiality with respect to Your Content.

6. Restrictions

We are under no obligation to enforce the Terms of Service on your behalf against another user. While we encourage you to let us know if you believe another user has violated the Terms of Service, we reserve the right to investigate and take appropriate action at our sole discretion.

1. You agree not to, and will not assist or enable others to:
 1. Violate the Terms of Service;
 2. Modify, adapt, appropriate, reproduce, distribute, translate, create derivative works or adaptations of, publicly display, sell, trade, or in

any way exploit the Service or Site Content (other than Your Content), except as expressly authorized by Booksource;

3. Use any robot, spider, site search/retrieval application, or other automated device, process or means to access, retrieve, scrape, or index any portion of the Service or any Site Content;
4. Reverse engineer any portion of the Service;
5. Remove or modify any copyright, trademark or other proprietary rights notice that appears on any portion of the Service or on any materials printed or copied from the Service;
6. Reformat or frame any portion of the Service;

1. Other Agreements

Any purchases made through Booksource or the Service may be subject to separate terms and conditions agreed to by Booksource and you. To the extent the provisions of these Terms of Service conflict with any such other terms and conditions agreed to between the parties, the provisions of such other terms and conditions shall control and prevail. To the extent the provisions of these Terms of Service do not conflict with any such other terms and conditions agreed to between the parties, the provisions of these Terms of Service shall apply.

2. Privacy

You represent that you have read and understood our Privacy Policy. Note that we may disclose information about you to third parties if we have a good faith belief that such a disclosure is reasonably necessary to (i) take action regarding suspected illegal activities; (ii) enforce or apply our Terms of Service and Privacy Policy; (iii) comply with legal process or other government inquiry, such as a search warrant, subpoena, statute, judicial proceeding, or other legal process served on us; or (iv) protect our rights, reputation, and property, or that of our users, affiliates, or the public. If you use the Service outside of the United States, you consent to having your personal data transferred to and processed in the United States.

8. eBook End User License Agreement

1. Use of e-books is for your personal educational and non-commercial use only.
2. You are prohibited from selling, distributing, sharing, e-mailing, posting, making publicly accessible, uploading, burning to a disk, or printing e-books.
3. You are prohibited from disabling or circumvention of DRM (Digital Rights Management) or security for e-books
4. You may keep an e-book checked out for the duration of your School's applicable e-book check-out period. After the earlier of the expiration of that check-out period or your return of that e-book you have no right to download or

- access the e-book, and upon the expiration of that check-out period such e-book may automatically or remotely be removed from your personal electronic reading devices and any devices on loan to you from the school, school library or library's e-book distributor.
5. You do not have any promotional use rights in e-books.
 6. Use of e-books is only for individuals who are current students, faculty or staff at the school.
 7. Use of e-books on more than six (6) non-internet-connected reading devices is prohibited.
 8. You may access on, download to and read e-books on only those personal electronic reading devices (including hand held devices and personal computers) that are registered to you, or that are on loan from your school library, school or library's e-book distributor.
 9. The school, school library, publisher or distributor of the e-book, may elect to cease making e-books, or any particular e-book, available to you at any time. Your ability to access, download or read e-books may be revoked at any time for any reason or no reason, without notice, and upon such revocation e-books may automatically or remotely be removed from your personal electronic reading devices and any device on loan to you from the school, school library or library's e-book distributor.
 10. This EULA is for the benefit of the school, school library, publisher, and distributor of the e-book, and any of them may take action against you for a violation.

School Agreement Terms

1. The School Agreement shall provide at a minimum the following terms, in substance:
2. The School shall supply Distributor with geographic information on its Library Users sufficient to enable Distributor to screen and block downloads and access outside the Territory. The School shall take reasonable steps to make sure that only those individuals who are currently enrolled students, current member of the faculty, or current staff members and , who meet the School's established criteria are given the rights of Library Users with respect to Publisher E-Books.

3. The School shall not, and shall not authorize, enable or encourage Library Users to, (a) use Publisher E-Books other than within the limits set by Publisher for each Check Out, nor (b) disable or circumvent DRM or security for Publisher E-Books. The School will immediately notify Distributor of any breach or suspected breach of security (including without limitation any unauthorized use, disclosure or acquisition of or access to Publisher E-Books, or disabling or circumvention of DRM with respect to Publisher E-Books, of which School becomes aware.
4. The School represents that it is a single school or school district teaching on a K-12 (kindergarten through twelfth grade) level or part of that level, that has physical classrooms for teaching by faculty to students (a **"School Building"**) in the Territory, with substantially all of the teaching conducted in such School Building and not in a virtual or on-line environment.
5. All rights in the Publisher E-Books not specifically granted in the School Agreement are reserved by the Publisher.
6. The School shall not authorize or enable use, display, posting, access to or downloading of Promotional Excerpts except on the School's or Distributor's systems (including websites, platforms and apps.) and solely for the purpose of describing School's e-book offerings to Library Users and to enable Library Users to browse and search for e-books to check out.
7. The School acknowledges and agrees that its agreement with Distributor is for the benefit of Distributor and Publisher, and that Distributor and Publisher, jointly or severally, may avail themselves of any remedies available in the agreement or by law, including without limitation the initiation of legal proceedings.
8. The School acknowledges and agrees that Distributor or Publisher may, with or without cause on two (2) business days notice (or under certain circumstances such as a security breach effective immediately without notice), suspend or withdraw any or all Publisher E-Books.

9. Teacher Resources Terms

1. Use of Teacher Resources is for your personal educational and non-commercial use only. All materials published on or provided through the Service (including, but not limited to photographs, images, illustrations, audio clips, video clips and teacher guides) are protected by copyright, and owned or controlled by Booksource, the respective authors, publishers or the party credited as the provider of the Content. You shall abide by all additional copyright notices, information, or restrictions contained in any Content accessed through the Service.
2. You are prohibited from selling, publishing, distributing, posting, making publicly accessible, uploading or burning to a disk any of the Content (except as stated in Section 9.3 below).
3. You may download or copy the Content for personal educational and non-commercial use only, provided that you maintain all copyright and other notices contained therein. Copying or storing of any Content other than for this specified personal educational and non-commercial use, as well as any other use of the Content, is expressly prohibited without prior written permission from Booksource and any other copyright holder identified in the copyright notice indicated for the Content. 4. Booksource may elect to cease making Teacher Resources available to you at any time.

11. Third Parties

The Service may include links to other websites or applications (each, a "Third Party Site"). We do not control or endorse any Third Party Site. You agree that we are not responsible for the availability or contents of such Third Party Sites. Your use of Third Party Sites is at your own risk. Some of the services made available through the Service are provided in connection with third parties and subject to additional terms posted here which are incorporated herein by reference.

12. Indemnity

You agree to indemnify and hold Booksource, its parents, subsidiaries, affiliates, any related companies, suppliers, licensors and partners, and the officers, directors, employees, agents and representatives of each of them harmless, including costs, liabilities and legal fees, from any claim or demand made by any third party due to or arising out of (i) your access to or use or misuse of the Service, (ii) your violation of the Terms of Service, or (iii) the infringement by you, or any third party using your account, of any intellectual property or other right of any person or entity. Booksource reserves the right, at your expense, to assume the exclusive defense and control of any matter for which you are required to indemnify us and you agree to cooperate with our defense of these claims. You agree not to settle any matter without the prior written consent of Booksource. Booksource will use reasonable efforts to notify you of any such claim, action or proceeding upon becoming aware of it.

13. No Warranty

FOR ANY CLAIM BROUGHT BY EITHER PARTY, YOU AGREE TO SUBMIT AND CONSENT TO THE PERSONAL AND EXCLUSIVE JURISDICTION IN, AND THE EXCLUSIVE VENUE OF, THE STATE AND FEDERAL COURTS LOCATED WITHIN SAINT LOUIS CITY, MISSOURI.

16. Termination

1. You may terminate the Terms of Service at any time by discontinuing your use of the Service.
2. Booksource may, in its sole discretion, alter, modify or suspend your ability to use the Service without giving any prior notice to you for the repair, maintenance or upgrade of the Service. We reserve the right to modify, update, or discontinue the Service at our sole discretion, at any time, for any or no reason, and without notice or liability.
3. In the event of any termination, whether by you or us, these Terms of Service will continue in full force and effect, including our right to use Your Content as detailed in Section 5.

17. General Terms

1. We reserve the right to modify, update, or discontinue the Service at our sole discretion, at any time, for any or no reason, and without notice or liability.
2. We may provide you with notices, including those regarding changes to the Terms of Service by email, regular mail or communications through the Service.
3. Except as otherwise stated in Section 9 above, nothing herein is intended, nor will be deemed, to confer rights or remedies upon any third party.
4. The Terms of Service contain the entire agreement between you and us regarding the use of the Service, and supersede any prior agreement between you and us on such subject matter. The parties acknowledge that no reliance is placed on any representation made but not expressly contained in these Terms of Service.
5. Any failure on Booksource's part to exercise or enforce any right or provision of the Terms of Service does not constitute a waiver of such right or provision. The failure of either party to exercise in any respect any right provided for herein shall not be deemed a waiver of any further rights hereunder.
6. If any provision of the Terms of Service is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that the Terms of Service shall otherwise remain in full force and effect and enforceable.
7. The Terms of Service are not assignable, transferable or sub licensable by you except with Booksource's prior written consent, but may be assigned or transferred by us without restriction. Any assignment attempted to be made in violation of the Terms of Service shall be void.
8. The section titles in the Terms of Service are for convenience only and have no legal or contractual effect.
